

What is Technology in Investment Management?

Technology in Investment Management has been developed for IT staff working in financial services, who wish to develop their knowledge and understanding of IT needs specific to the financial services arena. The securities sector is dependent on technology and this qualification aims to address the challenges of managing IT systems and covers best practice techniques used in financial services.

This specialist qualification provides firms with a benchmark from which to assess an employee's knowledge and competence and offers those engaged in IT a broader understanding of the information technology needs of a firm in this sector.

Who should study for the qualification?

Suitable for all staff working in IT within the financial services sector. It is of particular interest to those who are new to, or hoping to move into, financial services.
